The appointees shall be allowed to join only on production of the following certificates in original:

- i. Date of birth certificate
- ii. Qualification certificate
- iii. Permanent resident certificate issued by the competent authority.
- iv. Health certificate
- v. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
- vi. Relevant category certificate, where applicable.
- vii. Any other documents as required under rules.

2. The appointment of candidates is subject to verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
3. The salary of the appointees shall not be drawn and disbursed to him/her unless the satisfactory report in respect of qualification certificates and the reserved category certificates.
4. The appointment of the candidates shall be governed by *SO-194 of 2020 dated 17-06-2020*.
5. The appointees shall be governed by the "*New Pension Scheme*" as notified vide *SRO-400 of 2009 dated 24-12-2009*.
6. The appointment in Divisional cadre is not transferable from one Division to another or from one Medical College to another.
7. ✓ The appointment of the selected candidates shall further be subject to outcome of writ petitioner(s), if any, pending on the subject in any court of competent jurisdiction.
8. The inter-seniority of the above appointees shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Services Selection Board.


