Subject: Engagement of Senior Resident in Govt. Medical College, Doda in terms of SO 364 of 2020.

## ORDER

Sanction is hereby accorded to the engagement of Dr. Abhirut Thakur S/o Anjeel Kumar Thakur R/o Neota Udrana Tehsil Bhaderwah Doda, as Senior Residents in the department of Dermatology, in Government Medical College, Doda on tenure basis for a period of one year extendable up to three years.

The engagement of the Senior Resident shall, however, be following terms and conditions:

THIN I

- O1. The above said Doctor is directed to report Principal, Government Medical College, Doda within 7 days after the date of issuance of this engagement order, along with all the following certificates in original and three photocopies of each of them.
  - i. Date of birth certificate.
  - ii. Qualification certificates.
  - iii. Attempt certificate: any appeared to the angainment of Dr. Abhaut
  - iv. Registration certificate from MCI.
  - V. Domicile Certificate issued by the competent authority. Government
  - vi. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
  - vil. Any other documents as required under rules.
- O2. The tenure of Senior Resident shall be subject to the work and conduct, remaining satisfactory in the Associated Hospital, Govt. Medical College, Doda. In case of misconduct or negligence in duties or any resident found indulging in strike or any other activities which affect the hospital services/patient care, the appointment of doctors shall be terminated without any notice.
- 03. The Senior Resident shall be whole timer and shall not engage in private practice. In the event any doctor is found doing private practice, his/her appointment will be terminated without any notice and disciplinary action will be taken against them.
- 04. The Senior Resident shall be required to stay in the College/Hospital premises if residential accommodation is made available.

- 05. The Senior Resident shall be asked to give an undertaking in terms of SO-364 of 2020 dated:- 27.11.2020 to the effect that they have read the aforesaid terms and conditions and they shall abide by the same on an affidavit duly attested by the Magistrate before they are allowed to join.
- 06. The Senior Resident intending to leave the job shall have to provide one month's prior notice duly forwarded by the concerned HOD or else the doctor shall have to forfeit one month's salary, if they fail to do so.
- 07. No experience certificate will be issued before completion of tenure of one year except under compelling circumstances.
- 08. The above engagement shall be without prejudice to the outcome or Writ Petition (s), if any, pending consideration before the Court (S) of competent jurisdiction.
