The EOI from interested bidders will be opened at 1300 hrs of **19.12.2022** in the office of **Medical Superintendent of the Associated Hospital, Government Medical College Doda**. The interested bidder must read all the terms and conditions of EOI before submission of bids. The proposal may please be submitted in the format and schedule annexed to this document as Annexure-I, Annexure-II, Annexure-III along with supporting documents for the information provided.

The bidders are required to submit tenders with technical bid in sealed envelopes super-scribed as Technical Bid (Cover-A) and Financial Bid in another sealed envelope super-scribed as Price Bid (Cover-B). Both the Technical Bid (Cover-A) and Price Bid (Cover-B) envelopes be kept in a third big sealed envelope super-scribed as “**TENDER FOR EMPANELMENT OF LOCALLY AVAILABLE LICENSED DIAGNOSTIC LABORATORY AS VENDOR FOR EXTENDING INVESTIGATIVE FACILITIES TO BENEFICIARY PATIENTS**” on its top.

GENERAL TERMS AND CONDITIONS

The terms and conditions are as under:

1. The vendor bid must reach the office of the Medical Superintendent, Associated Hospital, Govt. Medical College Doda (J&K) on or before scheduled last day of submission.
2. The bids received after the deadline & Unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this office will not be responsible. The offer submitted Fax/Email shall not be considered and no correspondence will be entertained in this matter.
3. The quotations must be in the enclosed prescribed Performa on the letter head of the vendor duly signed by the Owner or his/her authorized representative. In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
4. The envelope containing bid must be handed over to the Office of Medical Superintendent, Associated Hospital, Govt. Medical College Doda (J&K) against proper receipt.
5. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
6. The vendor Diagnostic Laboratory must be situated within Municipal Limits of Doda Town.
7. The vendor Diagnostic Laboratory must hold valid licenses as on the date of submission of bid in specified forms issued by the Competent Authority under the provisions of the J&K Nursing Homes & clinical Establishments Act 1963 and Rules.
8. The successful Bidder will further ensure that their licenses remain valid on the date of bid opening and till the end of the contract period if it ends before contract period.
9. The vendor should agree to provide all the Diagnostic Laboratory facilities that the Associated Hospital, Government Medical College Doda requisitions. Failure to do so after execution of the contract as described elsewhere in the document will result in automatic forfeiture of the Security Deposit /Performance Guarantee.
10. The vendor must not have been convicted by the Health and Medical Education Department authorities or its subordinate officers and no case should be pending under the J&K Nursing Homes & Clinical Establishments Act 1963 and Rules
11. The vendor Diagnostic Laboratory must have hired the services of doctor possessing Post Graduate Degree/ Diploma in Pathology/ Microbiology/ Biochemistry for performing tests & supervising test reports.
12. The vendor must not be debarred / black-listed by any Govt. / Semi-Govt. / Public Sector organization.
13. The vendor must hold valid GST Registration certificate.
14. The vendor must hold valid PAN card.
15. The vendor must hold valid Aadhaar card.
16. The vendor must submit Earnest Money Deposit (EMD) of Rs. 20,000/- (Rupees Twenty Thousand only) by Demand Draft/ Bankers Cheque with the bid. The Demand Draft/Bankers Cheque must be issued in favour of '**Medical Superintendent, Associated Hospital GMC Doda**, payable at Doda.
17. EMD deposited by the unsuccessful bidders will be refunded by way of handing over the original Demand Draft/ Bankers Cheque duly endorsed by the '**Medical Superintendent, Associated Hospital GMC Doda**'.

18. The Earnest Money of the Successful bidder will be adjusted against the Performance Security Deposit to be recovered from the running account bills. Under any circumstances, '**Medical Superintendent, Associated Hospital GMC Doda**' will not be liable to pay any interest on the EMD.
19. The Earnest Money of the Successful bidder will be adjusted against the Performance Security Deposit to be recovered from the running account bills. '**Medical Superintendent, Associated Hospital GMC Doda**' will not be liable to pay any interest on the EMD under any circumstances to successful or unsuccessful bidder. The instrument shall be valid for a period of 6 months from the last date for submission of tender. In the absence of EMD, the bid shall be summarily rejected.
20. The vendor must have proper space for collection, processing, testing and reporting facilities in the vendor's establishment.
21. The vendor or his/her representative must always be contactable/ reachable over phone and otherwise on all the days. Every vendor should have an official e-mail ID and official WhatsApp contact number. Requisition will be placed to vendor through email/ SMS/ WhatsApp / FAX to the vendor.
22. If the vendor fails to provide all the Diagnostic Laboratory facilities as per contract condition, the particular test facility shall be procured from the vendor next on the sequence list or in case of urgency it can be purchased from the market and difference in cost will be recovered from the vendor to whom the order is placed.
23. Award of contract will be given to the retail vendor offering maximum rebate on rate notified by J&K government vide Govt Order No 72-HME of 2019 dated 17-01-2019. Contract may be awarded to more than one participant if maximum rebate on rate offered is same. In case two or more vendors provide maximum rebate, the Order for tests will be placed on the vendor as per monthly rotation and periodicity fixed by Medical Superintendent.
24. Providing maximum rebate on rate will not be the only criteria for awarding of contract order unless the rates are reasonable & justified. The rebate quoted must be valid for a minimum of two years from the date of opening of the bid and silence of any bidder on this issue shall be treated as agreed with this condition.
25. The vendor must furnish Account details with the bid.
26. The vendor must be willing to provide cashless services to the beneficiary patients of AH GMC Doda on receipt of requisition for diagnostic test and no beneficiary patient shall be charged by the vendor.
27. In case the vendor charges a beneficiary patient in whose favour a requisition for diagnostic test is issued, then a penalty shall be imposed on vendor at the rate of ten times the amount collected by the vendor from beneficiary patient
28. The billing system on monthly basis payment will be made through NEFT on receipt of bills along with challan copies on monthly basis.
29. The vendor must not be a part of any cartel with other vendors and will be applying for empanelment under individual capacity
30. The vendor will pay GST regularly and shall show the same to hospital authorities when demanded
31. **Submitting false or incorrect or misleading information-** If any information or reports submitted by bidder is/ are found to be false or incorrect or misleading the then Medical Superintendent, Associated Hospital, Govt. Medical College Doda (J&K) has the right to reject the diagnostic laboratory facilities and cancel the order, and no claim for payment in this regard will be entertained.

32. Submission of bid- The bidder shall submit the bids with technical bid in sealed envelope super-scribed as Technical Bid (Cover-A) and price bid in another sealed envelope super-scribed as Price Bid (Cover-B) in respective envelop. Both Technical Bid (Cover-A) and Price Bid (Cover-B) envelopes shall be kept in a third larger sealed envelope super-scribed as **“TENDER EMPANELMENT OF LOCALLY AVAILABLE LICENSED DIAGNOSTIC LABORATORY AS VENDOR FOR EXTENDING INVESTIGATIVE FACILITIES TO BENEFICIARY PATIENTS”** on its top.

a) **Cover-A (Technical Bid)** must contain the following documents:

- 2) Self Attested Xerox copy of valid License issued by Competent Authority in favour of the Diagnostic Laboratory under the provisions of the J&K Nursing Homes & clinical Establishments Act 1963 and Rules.
- 3) Self Attested Xerox copy of valid & NMC/ MCI recognized Post Graduate Degree/ Diploma in Pathology/ Microbiology/ Biochemistry of the doctor whose services have been hired for performing test & supervising test reports.
- 4) Self Attested Xerox copy of valid agreement with the doctor whose services have been hired by the licensed diagnostic laboratory for performing test & supervising test reports of Pathology/ Microbiology/ Biochemistry.
- 5) Self Attested Xerox copy of GST Registration Certificate of the Diagnostic Laboratory
- 6) Self Attested Xerox copy of PAN Card of the bidder
- 7) Self Attested Xerox copy of AADHAAR Card of the bidder
- 8) Account Payee Demand Draft worth Rs 20000 (Twenty thousand) drawn in favour of Medical Superintendent, Associated Hospital Government Medical College, Doda payable at any nationalized bank as EMD
- 9) An undertaking in the shape of affidavit as per the attached format (Annexure-II) to be submitted by the vendor to the effect that
 - i. If any information submitted by bidder is found to be false or incorrect or misleading at any point of time the then Medical Superintendent, Associated Hospital, Govt. Medical College Doda (J&K) has the right to reject the bid and no claim for payment in this regard will be entertained.
 - ii. The bidder has not been convicted by the convicted by the Health and Medical Education Department authorities or its subordinate officers and no case should be pending under the J&K Nursing Homes & clinical Establishments Act 1963 and Rules
 - iii. The bidder has not been debarred / black-listed by any Govt. / Semi-Govt. / Public Sector organization.
 - iv. The bidder has read all the terms and conditions of the bid and the bidder agree to abide by all the terms and conditions and shall comply with the terms and conditions of the EoI as applicable.’

b) **Cover-B (Financial Bid)** must contain the following documents:

The bidders should furnish the percentage of discount on offering maximum rebate on rate notified by J&K government vide Govt Order No 72-HME of 2019 dated 17-01-2019 as per Annexure-III as whole.

The quotations containing the **“FINANCIAL BID”** must be in the enclosed prescribed Performa on the letter head of the store/ shop duly signed by the owner or their authorized representative. In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.

33. Opening of bids-

- i. The sealed 'bid' of all the bidders received before the deadline of submission date shall be entertained and opened in presence of the bidders on the date, time and place as notified and evaluated by the committee.
- ii. The bids received after the deadline & Unsealed shall not be entertained under any circumstances whatsoever. The offer submitted by post or Fax or Email shall not be considered and no correspondence will be entertained in this matter.
- iii. The sealed **Technical Bid (Cover-A)** of all the bidders received before the deadline of submission date shall be entertained and opened before **Financial Bid (Cover-B)** in presence of the bidders on the date, time and place as notified and evaluated.
- iv. The **Financial Bid (Cover-B)** of only those bidders who qualify in "TECHNICAL BID" evaluation by the concerned Committee shall be opened.
- v. The **Cover-B (Financial Bid)** of all those bidders who have failed to qualify in the "TECHNICAL BID" will not be opened under any circumstances.
- vi. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.

34. Rejection of bid- The bid is liable to be rejected if:

- i. The proposal is not submitted as per the requirements indicated in the Technical bid of the **EoI**.
- ii. Not in the prescribed format.
- iii. Not properly signed as per requirements.
- iv. Received after the expiry of the due date and time.
- v. All relevant supporting documents are not furnished.
- vi. There is overwriting or cutting in the rate.

35. Pricing-

- i. The AH GMC Doda will pay only Government Rate minus rebate (discount offered as percent of rate notified by J&K government vide Govt Order No 72-HME of 2019) as offered by the vendor.
- ii. The liability to pay any duties, levies or taxes leviable under the law would be that of vendor. No GST on rate offered by the bidder will be paid.
- iii. The vendor will also have to bear all expenses etc. connected with sample collection, packaging, processing, testing, and reporting, in connection with diagnostic test facility to beneficiary patients at any place specified by AH GMC Doda.

36. Period of Empanelment-

- a) The vendor shall be empanelled for a period of two years (Two years) from the date of signing of the contract from both the side.
- b) In case of termination of agreement before the expiry of agreed period, two month notice is to be given by either party with reason acceptable by both the parties.
- c) The period of the empanelment Agreement shall be valid as per the validity License certificate subject to satisfactory performance.
- d) The vendor should agree to deliver the test reports as per requisition.
- e) Post empanelment, failure to do so as described elsewhere in the document will result in automatic forfeiture of Performance Security Deposit.
- f) The vendor shall have to sign an agreement to extend all diagnostic facilities for the empanelment period on a Rs.100/- non-judicial stamp paper.
- g) The empanelment is also liable to be forfeited if the vendor:
 - i. Fail to adhere to the terms of the EoI, or
 - ii. Deliver any sub-standard, spurious reports, or
 - iii. Delays in reports or Overcharging

37. Regarding diagnostic testing and delivery of reports:

- i. The vendor will have to extend diagnostic laboratory test facilities 24 x 7 without any excuse.
- ii. The vendor shall have to extend diagnostic laboratory test facilities even during holidays, hartals, curfew, and bandhs and without any excuse.
- iii. The vendor shall have to extend life saving diagnostic laboratory test facilities by collecting sample within a short notice preferably within 10 minutes of being intimated and provide the test reports within 60 minutes except Biopsy and Culture sensitivity test
- iv. Diagnostic Test Reports will have to be supplied on the same day preferably within 60 minutes.
- v. Diagnostic Test Reports will have to be supplied through special messengers of the vendor by the vendor without extra cost.
- vi. Substandard or late Diagnostic Test Reports by vendor shall be rejected
- vii. On receipt of requisition order for extending diagnostic test facilities, the delivery of test report (except Biopsy/ Culture) in full shall be made urgently on the same day preferably within 30 minutes of requisition by the vendor.
- viii. The vendor must not stop the extension of diagnostic testing facilities to the beneficiary patients without giving 60 days prior notice.
- ix. The test reports to be supplied by vendor will be of standard quality and duly signed & stamped by the hired doctor possessing Post Graduate Degree/ Diploma in Pathology/ Microbiology/ Biochemistry without any excuse.
- x. The concerned designated official of Associated Hospital, Govt. Medical College Doda (J&K) will check the Diagnostic Test Reports thoroughly, if somehow it found any discrepancy and is not satisfied with the Diagnostic Test Reports supplied, then Medical Superintendent, Associated Hospital, Govt. Medical College Doda (J&K) has the right to reject and return the Diagnostic Test Reports and cancel the order, and no claim for payment in this regard will be entertained.

38. Presentation of Bills-

- i. The vendor shall present the bill to the designated person of the hospital for the Diagnostic Tests Reports made on monthly basis. The bill should clearly indicate the details of the Requisition (No & Date of PMJAY Cell), patient (Name, MRD No, PMJAY No), and Diagnostic Test done (name of the test, rate, discount amount, date of testing & and any other information required by AH GMC Doda.

- ii. The bills shall be supported by the original requisition slips duly signed by the designated / authorized person with date.
 - iii. Incomplete bills not accompanied by any of the particulars as mentioned above will not be entertained.
 - iv. The bill shall be supported by the requisition along with the verification from the authorized official of the Hospital

39. Payment-

- i. Payment of the bills presented by vendor will normally be arranged within 30 working days from the date of presentation of the bill.
- ii. The AH GMC Doda will pay only Government Rate minus rebate (discount offered as percent of rate notified by J&K government vide Govt Order No 72-HME of 2019) as offered by the vendor. No GST on rate offered by the bidder will be paid.
- iii. Electronic transfer of payment will be made to the empanelled vending establishment for which the same will provide requisite details of bank address, account no. etc.
- iv. No advance payment shall be made. The vendor shall not demand any advance payment for any supply order.
- v. The billing system should not be discontinued by vendor even if payment is delayed in extraordinary circumstance due to system handicap of financial crunch for some time.

40. Corrupt, Fraudulent or Unethical Practices-

- i. AH GMC Doda requires that the vendor observe the highest standards of ethics during the extension of diagnostic services and execution of Agreement.
- ii. The test reports to be supplied by vendor will be of standard quality and duly signed & stamped by the hired doctor possessing Post Graduate Degree/ Diploma in Pathology/ Microbiology/ Biochemistry.
- iii. The vendor shall not resort to offering, giving, receiving or soliciting of anything of value to influence the action of any official of AH GMC Doda in the empanelment process or in Agreement execution.
- iv. The vendor shall not resort to misrepresentation of facts in order to influence the empanelment process or execution of Agreement to the detriment of AH GMC Doda.
- v. AH GMC Doda will declare a vendor ineligible, either indefinitely or for a specified period of time, for award of the Agreement, if at any time, it determines that the vendor has engaged in corrupt and fraudulent practices in executing the Agreement.
- vi. AH GMC Doda may, without prejudice to any other remedy for breach of Agreement, at its sole discretion, terminate the Agreement in whole or part in respect of any vendor for any of the following reasons:
 - a) supply of sub-standard/ spurious or fake test reports
 - b) unusual delay in reports/ refusal to supply reports / non-supply of test reports
 - c) over charging in the bill,
 - d) in case it is found that any particular test report's date is received beyond expected time
 - e) if the vendor fails to perform any other obligation(s) under the Agreement in the judgement of the AH GMC Doda has engaged in corrupt or fraudulent practices.
- vii. If any such case indicated in (vi) above is noticed during subsequent scrutiny

after or before the payment, then the vendor shall refund the disputed/excess amount already paid by AH GMC Doda.

- viii. GMC Doda may stop payments due or recover the cost of such test reports from the amounts due to the vendor

41. Applicability of best prices- If the vendor with whom the AH GMC Doda has entered into a contract & offers a higher discount to any person or organization during the currency of the rate contract, the discount rate applicable to the AH GMC Doda will be automatically increased with effect from that date for all the subsequent requisitions under the contract and the contract amended accordingly.

42. Liquidated Damage-

- i. If the vendor fails to supply Diagnostic Test Reports as per contract condition, the particular Diagnostic Test Reports shall be procured from the vendor next on the sequence list of rotation or in case of urgency it can be purchased from the open market and difference in cost will be recovered from the vendor to whom the order is placed.
- ii. If vendor fails to deliver the Diagnostic Test Reports in time, then a penalty at the rate of 10% per episode of the total order value shall be levied
