The engagement of the Junior Residents shall, however be on following terms and conditions:

- The above said candidates are directed to report Principal, Government 01. Medical College, Doda within 7 days after the date of issuance of this engagement order, along with all the following certificates in original and three photocopies of each of them along with three file covers.
 - Date of Birth Certificate/ 10th Marks Sheet i.
 - ii. 10th Diploma.
 - 12th marks sheet/Diploma. iii.
 - MBBS Marks Sheet (all semesters) iv.
 - MBBS Degree ٧.
 - Qualification Certificates/Degree. vi.
 - Registration certificate. vii.
 - viii. Experience certificate if any.
 - ix. Domicile Certificate.
 - Affidavit under SO-364 of 2020. x. xi.
 - Any other documents as required under rules. xii.
 - Pan Card, Aadhar Care, J&K Bank pass book copy.
 - xiii. Three passport size photographs.

The tenure of Junior Residents shall be subject to the work and conduct, remaining satisfactory in Govt. Medical College, Doda. In case of misconduct or negligence in duties or resident found indulging in strike or any other activities which affect the department / teaching process, the engagement of doctor shall be terminated without any notice.

- O3. The Junior Residents shall be whole timer and shall not engage themselves in private practice. In the event of doing private practice, the engagement of the doctor will be terminated without any notice and disciplinary action will be initiated against him/her.
 O4. The Junior Residents shall be against him/her.
- 04. The Junior Residents shall be required to stay in the College premises if residential accommodation if it is made available.
- 05. The Junior Residents shall be asked to give an undertaking to the effect that they have read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by the Magistrate before they are allowed to join.
- 06. The Junior Residents intending to leave the job shall have to provide onemonth prior notice duly forwarded by the concerned HOD or else the doctor shall have to forfeit one month's salary, if he / she fail to do so.
- 07. No experience certificate will be issued before completion of tenure of one year except under compelling circumstances.
- 08. The above engagement shall be without prejudice to the outcome or Writ Petition (s), if any, pending consideration before the Court (S) of competent jurisdiction.
