**Subject:- Important instruction regarding the examination for various posts on academic arrangement basis in terms of SO 364 of 2020 in Government Medical College Doda.**

**NOTICE**

It is for the information to all the candidates that a Common Entrance Test (objective based written test) is scheduled to be held on **04<sup>th</sup> of February 2024** for all the posts (except ECG Technician) advertised by this office vide Advertisement Notice No:- 09 GMCD Of 2023 Dated: 18 -08-2023.

Further, the Admit card to all the candidates shall be issued by this office w.e.f **29-01-2024 to 03-02-2024** (during office hours). Candidates are advised to bring **fee receipt, two passport size photos along with Aadhar card** to collect their Admit cards from establishment section of Government Medical college, Ghat Doda during the said period.

**Important instructions to Candidates.**

- 1) The candidate must reach the Examination Centre at least one hour before the exam time as indicated in the Admit Card.
- 2) No candidate shall be permitted to leave the Examination Room/ Hall before the end of the Examination.
- 3) Upon completion of the examination, please wait for instructions from Invigilator and do not get up from your seat until advised. The candidates will be permitted to move out, only after the completion of the examination.
- 4) The Admit Card is provisional and is subject to satisfying the eligibility conditions as given in the advertisement notification.
- 5) The Admit Card is valid only for the stipulated date, time and venue.
- 6) The Candidates are advised to verify the location of the Test Centre Venue, a day in advance so that they do not face any problem/inconvenience in accessing it ,on the day of the Test.
- 7) **NO REQUEST FOR CHANGE IN EXAMINATION CENTRE SHALL BE ENTERTAINED.**
- 8) No Candidate would be allowed to enter the Examination Centre, without Admit Card , Valid ID Proof, and proper frisking.
- 9) The Candidates will be permitted to carry only the following items with them into the examination venue:
  - a. Personal transparent water bottle,
  - b. Personal hand sanitizer.
  - c. A simple Blue/Black Ball Point Pen.
  - d. Original valid ID proof.
- 10) The Candidates are NOT allowed to carry any other personal belongings including electronic devices, or mobile phones to the Examination Centre. Examination Officials

will not be responsible for the safekeeping of personal belongings and there will be no facility for their safe storage.

- 11) The Candidates may be debarred and disqualified from the examination for any of the following reasons:
  - a) Attempting the examination for someone else, that is, impersonation.
  - b) Giving or receiving assistance of any kind during the examination & communication in any form to/from other candidates or outsiders.
  - c) Leaving the test Centre without permission.
  - d) Exchanging any papers, documents or any other material with other candidates or found to change the Seat allotted.
  - e) Using prohibited aids, items not allowed, such as:
    - i) Communication / pervasive devices like mobile phone, camera, digital watch, smart watch, Bluetooth device, ear phone, microphone, pager, health band.
    - ii) Printed or handwritten material, bits of paper, Calculator, Pen Drive, eraser, Log Table, electronic pen or scanner.
    - iii) Failing to follow instructions given by invigilators or is found indulging in any unfair means.
- 12) No Candidate should adopt any unfair means or indulge in any unfair examination practices.
- 13) The candidature of the candidates claiming eligibility by misrepresenting / concealment of any material / facts, impersonation, fraud, etc shall be liable for cancellation and disciplinary action, as deemed appropriate.
- 14) The Principal, Government Medical College, Doda reserves the right to cancel the candidature of any candidate at any stage at which he / she is found ineligible.
- 15) The time and venue of the examination shall be notified on the Admit card issued to the candidates.
- 16) The Candidates are advised to check updates on GMC Doda website, i.e., regularly.


