## <u>O R D E R</u>

Sanction is hereby accorded to the temporary engagement of **Dr. Aryan Dev Manhas S/o Sandeep Manhas R/o Mohalla Khakal, Bhaderwah, Doda** as Medical Officer in Addiction Treatment Facility (ATF), under National Drug Dependence Treatment Centre (NDDTC) in Government Medical College, Doda initially for a period of one year extendable on yearly basis subject to good performance and conduct till the continuation of centrally sponsored scheme, whichever is earlier.

The selection of Medical Officer, shall strictly governed by the following terms and conditions:

- The above selection of candidate is in Addiction Treatment Facility (ATF) under National Drug Dependence Treatment Centre (NDDTC) is provisional and subject to the production and verification of all requisite original documents.
- The selected candidate is advised to join in the Office of Principal, Government Medical College, Doda within 21 days after the issuance of this order.
- 3. The monthly remuneration of the hired candidate shall be released under National Drug Dependence Treatment Centre (NDDTC), New Delhi.
- 4. The selected candidate shall have to furnish an affidavit to the extent that he / she will not claim regular appointment on the said post on the strength of contractual engagement.
- 5. The engagement shall be terminated on one-month prior notice from either side by the competent authority at any time by giving one month prior notice to the candidate. In the event of leaving of job, the candidate shall have to give one-month prior notice or on payment of one month salary in lieu of notice by the appointing authority.

If the contractual engagee at any point of time willfully neglects or refuses to perform his / her duties, the appointing authority shall immediately terminate the engagement without any notice and he / she shall not be entitled to any salary of such period.

- 7. In case of poor performance, services of the candidate are liable to be terminated without any prior notice.
