The engagement of the Tutor / Demonstrator shall, however be on following terms and conditions:

- 01. The above said doctor is directed to report Principal, Government Medical College, Doda within 7 days after the date of issuance of this engagement order, along with all the following certificates in original and three photocopies of each of them along with three file covers.
 - Date of Birth Certificate.
 - ii. Qualification Certificates/Degree.
 - iii. All Marks sheets of MBBS (MD/MS Degree)
 - iv. Internship certificate.
 - Registration certificate.
 - vi. Experience certificate if any.
 - vii. Domicile Certificate.
 - viii. Affidavit under SO-364 of 2020.
 - ix. Any other documents as required under rules.
 - x. Pan Card, Aadhar Care, J&K Bank pass book copy.

- The tenure of Tutor / Demonstrator shall be subject to the work and conduct, remaining satisfactory in Govt. Medical College, Doda. In case of misconduct or negligence in duties or resident found indulging in strike or any other activities which affect the department / teaching process, the engagement of doctor shall be terminated without any notice.
- O3. The Tutor / Demonstrator shall be whole timer and shall not engage themselves in private practice. In the event of doing private practice, the engagement of the doctor will be terminated without any notice and disciplinary action will be initiated against him/her.
- O4. The Principal, Govt. Medical College, Doda reserves the right to terminate the engagement of the doctor, if the concerned HOD furnishes adverse or unsatisfactory work done report of the doctor.
- 05. The Tutor / Demonstrator shall be required to stay in the College premises if residential accommodation is made available.
- Of. The Tutor / Demonstrator shall have to tender an undertaking in terms of SO-364 of 2020 dated: 27.11.2020 to the effect that he/she has read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by the Magistrate before they are allowed to join.
- 07. The Tutor / Demonstrator intending to leave the job shall have to provide one-month prior notice duly forwarded by the concerned HOD or else the doctor shall have to forfeit one month's salary, if he / she fail to do so.
- 08. No experience certificate will be issued before completion of tenure of one year except under compelling circumstances.
- 09. The above engagement shall be without prejudice to the outcome or Writ Petition (s), if any, pending consideration before the Court (S) of competent jurisdiction.
