**Subject: Cancellation of candidature of candidate for the post of Technical Assistant, advertised on academic arrangement basis in terms of S.O 364 of 2020 in Government Medical College, Doda.**

**NOTICE**

*Whereas*, this office has advertised various posts of Non gazetted staff on academic arrangement basis vide Advertisement Notice No: 09-GMCD of 2023 dated: 18-08-2023;

*Whereas*, enormous number of applications were received for different categories of posts;

*Whereas*, Ms Kajal Parihar had also applied for the post of Junior Staff Nurse vide application form S.No 720;

*Whereas*, her application form was placed inadvertently among the application forms for the post of Technical Assistant instead of the application forms of Junior Staff Nurse.

*Whereas*, this office proceeded for Common Entrance Test for different category of posts on 04<sup>th</sup> of February 2024;

*Whereas*, the Question paper for all the posts was same;

*Whereas*, the merit / provisional list of all the candidates was issued by this office vide No: GMC/D/Adm/346/4255-61 Dated: 09.03.2024;

*Whereas*, this office issued a notice on the same day for submission of objections from all the candidates regarding any kind of objections in the provisional merit list vide No: GMC/D/Adm/364/4262-67 Dated: 09.03.2024;

*Whereas*, this office received only six (06) representation / objections from the candidates regarding the provisional merit list;

*Whereas*, Ms. Kajal Parihar neither submitted her representation / objection nor report this office with regard to provisional merit list as well as provisional selection to the post of Technical Assistant / Technician instead of Junior Staff Nurse;

*Whereas*, after considering the representation of the candidates this office issued a revised / final selection list vide No: GMC/D/Adm/346/282-88 Dated: 20.04.2024 with the directions to all the selected candidates to report for CID verification along with their documents verification to ascertain the eligibility of all selected candidates so that the formal engagement order may be issued in favour of eligible candidates;

**Whereas,** the candidate in question reported to this office for documents verification and after going through her documents it was found that the candidate had applied for the post of Junior Staff Nurse but her candidature was considered inadvertently for the post of Technical Assistant / Technician;

**Whereas,** this office again reviewed the merit list for the post of Junior Staff Nurse and the said candidate's merit was found to be 70.5 points whereas the cut off point for the post of Junior Staff Nurse 74.5;

**Therefore,** in view of above, the provisional selection of the candidate namely Ms. Kajal Parihar for the post of Technical Assistant / Technician figuring at S. No. 10 is hereby cancelled ab-initio;
