01. These Senior Resident/Tutor/Demonstrator are directed to report Principal, Government Medical College, Doda within 07 days after the date of issuance of this appointment order along with all the below mentioned documents in original as well as three photocopies of all educational and other concerned certificates.
 - I. Date of birth certificate.
 - II. Qualification certificates (MBBS/MD) along with degree.
 - III. Domicile Certificate.
 - IV. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
 - V. Relevant category certificate, where applicable.
 - VI. Affidavit from 1st Class Magistrate.
 - VII. Any other documents as required under rules.
2. Each Senior Resident/Tutor/Demonstrator shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the inspector General of Police (CID), J&K to whom a reference shall be made by this office, the candidate shall have no right claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
3. The appointment of these Senior Resident/Tutor/Demonstrator is subject to verification/genuineness of the qualification certificates from the concerned issuing authorities.

The salary of these Senior Resident/Tutor/Demonstrator shall not be drawn and disbursed to them unless the satisfactory report in respect of (2) and (3) above are received in their favour.

5. The tenure of Senior Resident/Tutor/Demonstrator shall be subject to work and conduct of the Senior Resident/Tutor/Demonstrator in Govt. Medical College, Doda remaining satisfactory during their tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the hospital services/patient care, the tenure appointment of doctors shall be terminated without any notice.
6. These Senior Resident/Tutor/Demonstrator shall be whole timer and shall not engage him/herself in private practice. In case of these doctors found resorting to private practice their tenure of appointment will be terminated without any notice and disciplinary action will be taken against them.
7. These Senior Resident/Tutor/Demonstrator shall be required to stay in the College/Hospital premises if residential accommodation is available.
8. No Senior Resident/Tutor/Demonstrator appointed under this order shall be allowed to apply for any job during the tenure of Registrar ship/Tutor ship.
9. These Senior Resident/Tutor/Demonstrator shall have to reside within or near College Campus.
10. Any Senior Resident/Tutor/Demonstrator intending to leave the job shall have to provide one month's prior notice duly forwarded by the concerned HOD or else the Doctor shall have to deposit one month's salary in this institution. Further, one month's salary of appointees shall be kept withheld as security.
11. No experience certificate will be issued before completion of tenure of one year.
12. The above engagements shall be without prejudice to the outcome of Writ Petition(s), if any, pending consideration before the Court(s) of competent jurisdiction.
