Pursuant to the approval conveyed by the Administrative Department vide letter No: ME/NG/191/2022-02 dated 27-01-2023 and clearance from CID Department vide No: 55690 Dated: 03.04.2023, sanction is hereby accorded to the temporary appointment of Sh. Suraj Kumar S/o Mani Ram R/o Sohanda, Samba, Samba for the post of "Manager Hostel" in the Govt. Medical College Doda, Divisional Cadre Jammu in the pay band of PB-II(9300-34800) with grade pay of Rs.4200 (Pre revised) now revised to Level 6 (35400-112400) with immediate effect.

The appointment of the candidate shall be subject to the following conditions:

1. The appointee is directed to report Principal, Government Medical College, Doda within 21 days after the date of issuance of this appointment order along with all the original certificates, three photocopies of all educational and other concerned certificates.

The appointee shall be allowed to join only on production of the following certificates in original:

- i. Date of birth certificate
- ii. Qualification certificate
- iii. Domicile certificate issued by the competent authority.
- iv. Health certificate
- v. Relevant category certificate, where applicable.
- vi. Affidavit from 1st class Magistrate.
- vii. That, if the candidate has taken loan for self employment from DIC / Employment Department to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling centre of the domicile district, he / she shall relinquish the proprietorship of unit / enterprise and also stakes, if any, in such self employment unit / enterprise before joining the Govt. Service. He/ she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his / her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a



- self employment unit / enterprise and recovery to be made and also personally monitor its recovery.
- viii. Any other documents as required under rules.
2. The appointment of candidate is subject to verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
 3. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of genuineness of document verification (02) is received in his favour.
 4. The appointment of the candidate shall be governed by **SO-425 of 2022 dated 06-09-2022.**
 5. The appointee shall be governed by the "**New Pension Scheme**" as notified vide **SRO-400 of 2009 dated 24-12-2009.**
 6. The appointment in Divisional cadre is not transferable from one Division to another or from one Medical College to another.
 7. The appointment of the selected candidate shall further be subject to outcome of writ petitioner(s), if any, pending on the subject in any court of competent jurisdiction.
 8. The inter-seniority of the above appointees shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Services Selection Board.
 9. The candidates who have fail to join this office within the stipulated time period of 21 days forego their right of appointment which shall be deemed to have been cancelled ab-initio without any further notice as per the instructions issued by the Gen. Administration Department vide circular No.08-JK(GAD) of 2019 dated 04-12-2019.
