
WHEREAS, the selection of **08 No's.** of candidates has been made by JKSSB against the post of of "Radiographic Technician" vide Advertisement/item No.011/04 of 2019 Divisional cadre, Jammu and the approval conveyed by the Administrative Department, Health and Medical Education J&K, Jammu to this office vide No. ME/NG/New GMC/03/2019-PF dated 18-03-2020 for issuance of the formal appointment orders in favour of the selected candidates.

WHEREAS, this office has issued formal appointment order in favour of **06 No's.** of appointed candidates vide order No. 04-NG of 2020 dated 09-04-2020 and the same has not been issued in favour of **02 No's.** of candidates as per the instructions of the Hon'ble High Court of Jammu and Kashmir vide WP(C) No. 703/2020, CM No. 1611/2020.

WHEREAS, the total number of posts for Radiographic Technicians are only **08** in Government Medical College Doda and prior to the selection made by JKSSB **08 No's** of Radiographic Technicians were appointed by this office under SRO—24 vide different endorsement numbers and they are working accordingly in Government Medical College Doda.

WHEREAS, **04 No's** of candidates have joined this office within the prescribed time period and the other two (**02**) no. of candidates are failed to do so.

WHEREAS, after the permanent appointment made by this office in favour of **06** candidates and in response of that only **04 No's** of candidates have joined this office. Further, **02 No.** of candidates have not joined this office so the total no. of the Radiographic Technicians increases to **12** which is exceeding the sanctioned strength of **08 No's** of Radiographic Technicians.
