Pursuant to the Administrative Department's letter No: ME/NG/New/GMC/03/2019 dated 12-05-2020 and the recommendations of the J&K Service Selection Board, Jammu vide No. SSB/Secy/Sel/J/80/2020/3086-92 dated 08-05-2020, sanction is hereby accorded to the temporary appointment of 10 candidates as per *Annexure I* to this order against the post of "Driver" in the Govt. 01. The appointees are directed to report Principal, Government Medical College, Doda within 21 days after the date of issuance of this appointment order along with all the original certificates, two photocopies of all educational and other concerned certificates.  
The appointees shall be allowed to join only on production of the following certificates in original:
  - i. Date of birth certificate
  - ii. Qualification certificate
  - iii. Permanent resident certificate issued by the competent authority.
  - iv. Health certificate
  - v. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
  - vi. Relevant category certificate, where applicable.
  - vii. Any other documents as required under rules.
02. Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the inspector General of Police (CID), J&K to whom a reference shall be made by this office, the candidate shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled *ab-initio*.
03. The appointment of candidates is subject to verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.

09. The inter-seniority of the above appointees shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Services Selection Board.

The candidates who have fail to join this office within the stipulated time period of 21 days forego their right of appointment which shall be deemed to have been cancelled *ab-initio* without any further notice as per the instructions issued by the General Administration Department vide circular No.08-JK(GAD) of 2019 dated 04-12-2019.
