It is for the information to all the candidates that a Common Entrance Test (objective based written test) is scheduled to be held on **15<sup>th</sup> of February, 2025** for tenure posts of Junior Residency advertised by this office vide Advertisement Notice issued by this office vide No: GMC/D/Adm/101/39-43 dated: 07.01.2025 & GMC/D/Adm/101/119-123. Further, the Roll No slips to all the candidates shall be issued by this office instantly at the time of registration of the candidates on 15<sup>th</sup> of January, 2025 at 10:00 AM. Candidates are advised to bring **Original Documents along with one complete set of photostat documents with Aadhar card** for registration in the establishment section of Government Medical college, Ghat Doda.

**Important instructions to Candidates.**

- 1) The candidate must reach the main campus of GMC Doda on time i.e. 10:00 AM
- 2) No candidate shall be permitted to leave the Examination Room/ Hall before the end of the Examination.
- 3) Upon completion of the examination, please wait for instructions from Invigilator and do not get up from your seat until advised. The candidates will be permitted to move out, only after the completion of the examination.
- 4) The Roll No slip is provisional and is subject to satisfying the eligibility conditions as given in the advertisement notification.
- 5) No Candidate would be allowed to enter the screening test without requisite documents and Admit Card.
- 6) The Candidates will be permitted to carry only the following items with them into the examination venue:
  - a. Personal transparent water bottle,
  - b. Personal hand sanitizer.
  - c. A simple Blue/Black Ball Point Pen.
  - d. Original valid ID proof.
- 7) The Candidates are NOT allowed to carry any other personal belongings including **electronic devices, or mobile phones** to the screening test. The Officials will not be responsible for the safekeeping of personal belongings and there will be no facility for their safe storage.
- 8) **Using prohibited aids, items not allowed, such as:**
  - i) Communication / pervasive devices like mobile phone, camera, digital watch, smart watch, Bluetooth device, ear phone, microphone, pager, health band.
  - ii) Printed or handwritten material, bits of paper, Calculator, Pen Drive, eraser, Log Table, electronic pen or scanner.
  - iii) Failing to follow instructions given by invigilators or is found indulging in any unfair means.
- 9) No Candidate should adopt any unfair means or indulge in any unfair examination practices.

- 10) The candidature of the candidates claiming eligibility by misrepresenting / concealment of any material / facts, impersonation, fraud, etc shall be liable for cancellation and disciplinary action, as deemed appropriate.
- 11) The Principal, Government Medical College, Doda reserves the right to cancel the candidature of any candidate at any stage at which he / she is found ineligible.
- 12) The Candidates are advised to check updates on GMC Doda website, i.e., regularly.
