The engagement of the Tutor / Demonstrator /Senior Residents shall, however be on following terms and conditions:

01. The above said Doctors are directed to report Principal, Government Medical College, Doda within 7 days after the date of issuance of this engagement order, along with all the following certificates in original and three photocopies of each of them.
 - i. **Date of Birth Certificate.**
 - ii. **Qualification Certificates/Degree.**
 - iii. **Experience certificate if any.**
 - iv. **Domicile Certificate issued by the competent authority.**
 - v. **Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.**
 - vi. **Affidavit under SO-364 of 2020**
 - vii. **Any other documents as required under rules.**

02. The tenure of Tutor / Demonstrator / Senior Residents shall be subject to the work and conduct, remaining satisfactory in the Associated Hospital, Govt. Medical College, Doda. In case of misconduct or negligence in duties or any resident found indulging in strike or any other activities which affect the hospital services/patient care, the appointment of doctors shall be terminated without any notice.
03. The Tutor / Demonstrator / Senior Residents shall be whole timer and shall not engage themselves in private practice. In the event, any doctor is found doing private practice, his/her engagement will be terminated without any notice and disciplinary action will be initiated against him/her.
04. The Tutor / Demonstrator / Senior Residents shall be required to stay in the College/Hospital premises if residential accommodation is made available.
05. The Tutor / Demonstrator / Senior Residents shall be asked to give an undertaking in terms of SO-364 of 2020 dated:- 27.11.2020 to the effect that they have read the aforesaid terms and conditions and they shall abide by the same on an affidavit duly attested by the Magistrate before they are allowed to join.
06. The Tutor / Demonstrator / Senior Residents intending to leave the job shall have to provide one month's prior notice duly forwarded by the concerned HOD or else the doctor shall have to forfeit one month's salary, if they fail to do so.
07. No experience certificate will be issued before completion of tenure of one year except under compelling circumstances.
08. The above engagement shall be without prejudice to the outcome or Writ Petition (s), if any, pending consideration before the Court (S) of competent jurisdiction.
