01. The above said selected Doctors are directed to report Principal, Government Medical College, Doda within 7 days after the date of issuance of this engagement order, along with all the following certificates in original and **three photocopies of each of them.**
 - i. **Date of Birth Certificate.**
 - ii. **Qualification Certificates/Degree.**
 - iii. **All Marks sheets of MBBS / Internship certificate.**
 - iv. **Registration certificate.**
 - v. **Experience certificate if any.**
 - vi. **Domicile Certificate.**
 - vii. **Affidavit under SO-364 of 2020.**
 - viii. **Any other documents as required under rules.**
02. The tenure of Junior Residents shall be subject to the work and conduct, remaining satisfactory in the Associated Hospital, Govt. Medical College, Doda. In case of misconduct or negligence in duties or any resident found indulging in strike or any other activities which affect the hospital services/patient care, the engagement of doctors shall be terminated without any notice.

03. The Junior Residents shall be whole timer and shall not engage themselves in private practice. In the event, any doctor is found doing private practice, his/her engagement will be terminated without any notice and disciplinary action will be initiated against him/her.
04. The Junior Residents shall be required to stay in and around the College / Hospital premises if residential accommodation is made available.
05. The Junior Residents shall be asked to give an undertaking in terms of SO-364 of 2020 dated:- 27.11.2020 to the effect that they have read the aforesaid terms and conditions and they shall abide by the same on an affidavit duly attested by the Magistrate before they are allowed to join.
06. The Junior Residents intending to leave the job shall have to provide one month's prior notice duly forwarded by the concerned HOD or else the doctor shall have to forfeit one month's salary, if they fail to do so.
07. The Junior Residents engaged above shall not claim any preferential treatment and their engagement is purely temporary and can be terminated at any time.
08. The above engagement shall be without prejudice to the outcome or Writ Petition (s), if any, pending consideration before the Court (S) of competent jurisdiction.
