- 2. The Senior Resident/Registrar is directed to report Principal, Government Medical College, Doda within 14 days after the date of issuance of this order along with the valid certificates and requisite Degree.
- 2. The tenure of Senior Resident/Registrar shall be subject to work and conduct of the Senior Resident/Registrar in the Associated Hospital, Govt. Medical College, Doda remaining satisfactory during his tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the hospital services/patient care, the tenure appointment of doctor shall be terminated without any notice.
- The Senior Resident/Registrar shall be whole timer and shall not engage himself in private practice. In case of the doctor found resorting to private practice their tenure of appointment will be terminated without any notice and disciplinary action will be taken against them.
- 4. The Senior Resident/Registrar shall be required to stay in the College/Hospital premises if residential accommodation is available.
- 5. No Senior Resident/Registrar appointed under this order shall be allowed to apply for any job during the tenure of Registrar ship/Tutor ship nor shall the controlling authority forward any such application to the concerned quarter if any.

- 6. The Senior Resident/Registrar shall be asked to give an undertaking to the effect that he has read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by the Magistrate before he is allowed to join. He shall submit his joining report to the Principal, Government Medical College, Doda only after a formal letter is sent to him after ensuring that all the requisite formalities have been completed.
 - 8. The Senior Resident/Registrar shall have to reside within or near College Campus.
 - 9. If Senior Resident/Registrar intends to leave the job he/ she shall have to provide one month's prior notice duly forwarded by the concerned HOD or else the Doctor shall have to deposit one month's salary in this institution. Further, one month's salary of appointees shall be kept withheld as security.
 - No experience certificate will be issued before completion of tenure of one year.
 - 11. The above engagements shall be without prejudice to the outcome of Writ Petition(s), if any, pending consideration before the Court(s) of competent jurisdiction.
